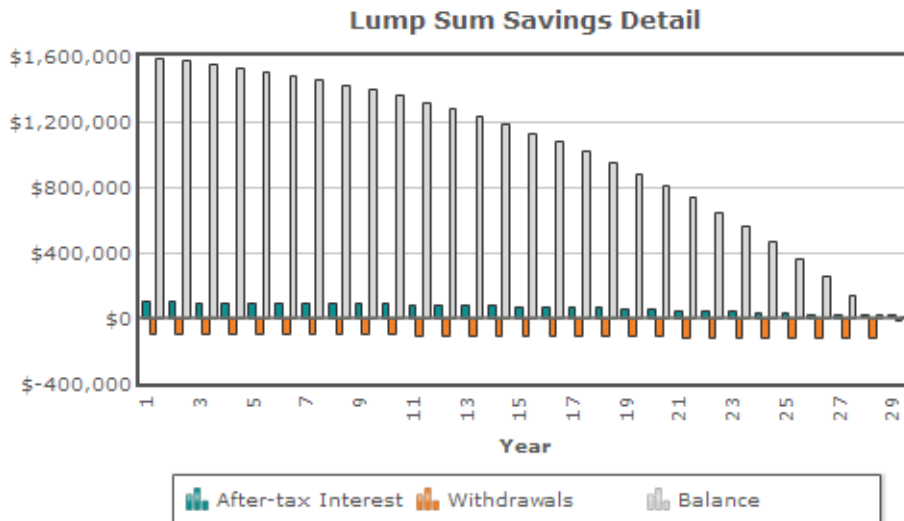
You have worked hard to accumulate your savings. Use this calculator to determine how long those funds will last given regular withdrawals.
