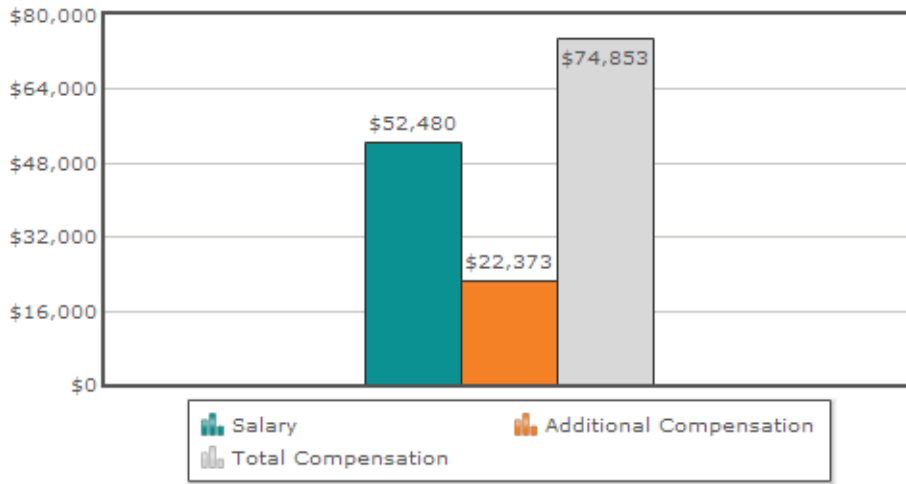
ANALYSIS
