INTRODUCTION

Compound interest can have a dramatic effect on the growth of an investment. Use this compound interest calculator to illustrate the impact of compound interest on the future value of an asset.



ANALYSIS

Compound interest is the difference between the cash you contribute to an investment and the actual future value of the investment. In this case, by contributing just \$0 per year with the annual contribution being increased by 0% per year (cumulative contributions of \$16,254) you are able to accumulate \$129,838 over 27 years. Compound interest makes up \$113,584 of your future balance.
